### ***Background / Justification:***

In the summer of 2015, Director Musteen and Parks Superintendent Rulo presented a concept plan for a Dog Park in the spillway area north of the Silver Lake Dam. Some discussion was held, but no further advancement in the project occurred.

Recently, the Silver Lake HOA has expressed interest in revisiting the proposed Dog Park at the Silver Lake Dam spillway location.

As presented in the February work session of the Raymore Park Board, the City would be open to exploring a lease agreement.

Staff is working with the City Attorney for a draft lease and will meet with Silver Lake HOA Board President in the coming weeks.


