AFFIDAVIT OF GUILTY PLEA AND WAIVER OF APPEARANCE

COMES NOW on this day of _____, I, _____, the named defendant in the above captioned matter, upon motion to this Court, by and through the advice and assistance of Attorney _____, hereby waive my in-person appearance in this Court. Furthermore, I knowingly, intelligently, and voluntarily enter a plea of guilty to:

Upon my plea of guilty, I understand:

- a) A plea of guilty waives my right to trial on the matters listed in this waiver.
- b) By pleading guilty, I give up the following rights:
 - a. I am giving up my right to a speedy, public, and fair trial.
 - b. I am giving up the right to the presumption of innocence.
 - c. I am giving up the right to place the burden of proof on the City to prove me guilty beyond a reasonable doubt.
 - d. I am giving up the right to a court-appointed attorney if I could not afford an attorney.
 - e. I am giving up my right to see, hear and ask questions of the witnesses who might be called to testify against me at trial.
 - f. I am giving up my right to subpoena my witnesses to my trial and my right to subpoena any evidence the prosecution may have that I would like to examine.
 - g. I am giving up my right against self-incrimination, meaning my right to remain silent and not testify or produce evidence at my trial without having this held against me.
 - h. I am giving up any right I may have to a jury trial.
 - i. I am giving up my right to appeal to a higher court if I am found guilty following trial.

- c) A plea of guilty in a moving traffic related matter may result in points assessed by the Missouri Department of Revenue which may result in a suspension or revocation of my driving privileges.
- d) A plea of guilty to the charge of Driving Under the Influence of alcohol or drugs (“DUI”), may cause my driving privileges to be revoked and could be later used to enhance any subsequent “intoxication-related traffic offense.”
- e) A plea of guilty to the offenses of driving while suspended/revoked, stealing or theft, assault, or possession of a controlled substance, could be later used to enhance any subsequent offense of that nature depending on the number of prior convictions.
- f) A plea of guilty may have an effect on my immigration status if I am not a permanent legal resident of the United States of America.
- g) I must successfully satisfy the conditions of probation to maintain good standing and to avoid revocation.
- h) Any revocation of a probation could lead to the execution of the punishment prescribed in the recommendation and the full range of punishment for a suspended imposition of sentence (“SIS”).
- i) I must pay any fines and costs associated with the above listed offenses and failure to pay may result in a probation violation if I am on probation, or a notice to show cause if the sentence is a fine.

Having fully discussed the details of the above listed offenses and all other considerations specific to myself with my attorney, I pray that this Court accept my plea of guilty and follow the recommendation reached between the defendant and the City Prosecutor’s Office.
